3. Kriteria pemilihan bagi jawatan ini adalah seperti berikut :



- ii) Mempunyai pemikiran dan sikap yang proaktif serta mampu mengurus kepelbagaian dalam apa jua situasi.

- iii) Seorang yang mempamerkan sifat kepimpinan melalui teladan kepada mereka yang dibawah pimpinannya.
  - iv) Mempunyai perwatakan yang dinamik serta bertanggungjawab dan komited kepada tugas dan tanggungjawab berdasarkan nilai-nilai murni masyarakat dan negara.
  - v) Berkeupayaan mengenalpasti konflik dan mengurusnya dengan baik serta berhemah.
  - vi) Mempunyai potensi untuk menyumbang secara berkesan terhadap pembangunan Universiti dan pendidikan tinggi negara secara keseluruhannya.
4. Sehubungan dengan itu, staf akademik yang berminat boleh mengemukakan permohonan masing-masing secara bersurat sebelum **4 Oktober 2016** untuk dipertimbangkan ke jawatan tersebut.
5. Surat permohonan tersebut hendaklah disertakan dengan lampiran berikut:
- i) *Curriculum Vitae* yang lengkap dan kemaskini;
  - ii) Anugerah dan hadiah yang berprestij di peringkat kebangsaan dan antarabangsa; dan
  - iii) Sumbangan-sumbangan besar dan bermakna bagi pembangunan Fakulti dan Universiti.
  - iv) Permohonan hendaklah menggunakan Borang A yang boleh dimuat turun melalui [registrar.utm.my/hcm/pentadbir-akademik](http://registrar.utm.my/hcm/pentadbir-akademik).
6. Semua permohonan untuk dipertimbangkan ke jawatan tersebut, hendaklah dimasukkan ke dalam sampul surat bertaraf – **SULIT** – dengan menulis jawatan yang dipohon di penjuru kanan sampul surat dan dihantar kepada Timbalan Pendaftar, Seksyen Governan, Pejabat Pendaftar UTM Johor Bahru sebelum tarikh tutup.
