BANTUAN KHAS KEWANGAN TAHUN 2021

Dimaklumkan bahawa Kerajaan melalui Belanjawan 2021 telah bersetuju supaya Bantuan Khas Kewangan Tahun 2021 dibayar kepada pegawai Perkhidmatan Awam Kumpulan Pengurusan dan Profesional serta Kumpulan Pelaksana Gred 56 dan ke bawah. Bayaran ini juga turut dipanjangkan kepada pesara Kerajaan yang menerima skim pencen dan veteran tidak berpencen melalui surat edaran oleh Ketua Pengarah Perkhidmatan Awam (JPA.800-3/2/1(20)) bertarikh 14 Disember 2020 mengenai Bantuan Khas Kewangan Tahun 2021.


2. Berdasarkan pekeling tersebut, Mesyuarat Lembaga Pengarah Universiti Bil. 110 bertarikh 5 Januari 2021 bersetuju supaya Bantuan Khas Kewangan ini dibayar kepada staf Universiti Teknologi Malaysia (UTM) gred 56 dan ke bawah bagi lantikan tetap, sementara dan *contract of service* sebanyak RM600.00. Pesara yang memilih skim pencen yang dilantik semula secara *contract of service* di UTM juga layak dibayar Bantuan Khas Kewangan sebanyak RM600.00. Walau bagaimanapun, pembayaran sebanyak RM300.00 akan dibayar oleh Jabatan Perkhidmatan Awam dan bakinya akan dibayar oleh UTM.

3. Sehubungan dengan itu, Bantuan Khas Kewangan Tahun 2021 ini akan dibayar pada 25 Januari 2021.

SPECIAL FINANCIAL ASSISTANCE YEAR 2021


Please be informed that the Government through the 2021 Budget has agreed that the Special Financial Assistance for the Year 2021 be paid to the Public Service officers of the Management and Professional Group as well as the Support Staff Group Grade 56 and below. This payment is also extended to Government retirees who receive a pension scheme and non-pensionable veterans through a circular letter by the Director General of Public Service (JPA.800-3 / 2/1 (20)) dated 14 December 2020 on the Special Financial Assistance Year 2021.

2. Based on the above circular, the University Board of Directors Meeting No. 110 dated 5 January 2021 agreed that this Special Financial Assistance be paid to Universiti Teknologi Malaysia (UTM) staff grade 56 and below for permanent, temporary and contract of service appointments of RM600.00. Retirees who choose a pension scheme and re-appointed as contract of service officer in UTM are also eligible for Special Financial Assistance of RM600.00. However, a payment of RM300.00 will be paid by the Public Service Department and the balance will be paid by UTM.
3. Accordingly, the Special Financial Assistance for the Year 2021 will be paid on 25 January 2021.
